



Permission, Medical, & Travel Release Form

Acknowledgement of Permission & Release:

As Parent/Guardian, of _____ (child's name) **I consent for my child to ride in RBC vehicles and/or adult chaperone's private vehicles and to participate in all related activities—outdoor games and bowling during our Back to School Bash Student Gathering Wednesday, August 16th, 2023.** I realize that there are risks associated with traveling in any motor vehicle. In the event of an accident or emergency involving my child in connection with these activities, I give my permission to the supervising adults to give or to seek whatever First Aid and/or Professional Medical Treatment they deem necessary. **I further authorize the supervising adults to make medical, safety, and behavioral decisions for my child/ren until I am present and able to do so.**

Furthermore, I agree to forever hold harmless and innocent Riverview Baptist Church, its pastors and members, agents, assignees, and all of the supervising adults of these trips from any and all liability associated with these trips. In consideration for being allowed to participate in this activity, on behalf of myself, my children, my next of kin, heirs and representatives, I release from all liability and promise not to sue Riverview Baptist Church, or any person affiliated with Riverview Baptist Church. **I fully understand this includes waiving my right to ALL legal claims (including claims of the church's negligence or negligence by an individual associated with Riverview Baptist Church) against Riverview Baptist Church or an individual associated with the church.**

I am voluntarily allowing my child to participate in these activities. I am aware of the risks associated with traveling to/from and participating in these activities, which include but are not limited to physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability (including paralysis), economic or emotional loss, and/or death. I understand that these injuries or outcomes may arise from my own, my child's, or other's actions, inaction, or negligence; conditions related to travel; or the condition of the Activity location(s). **Nonetheless, I assume all related risks, both known or unknown to me, of my child's participation in these activities, including travel to, from these activities.**

In summary, I understand the legal consequences of signing this document, including (a) releasing Riverview Baptist Church from all liability on my own behalf and on my child's behalf, (b) promising not to sue Riverview Baptist Church or individuals associated with the church on my own behalf and on my child's behalf, (c) and assuming all risks of participating in the above activities, including travel to, from and during said activities.
